III. WSCC Grant Addendum

- A. Hazard Mitigation Funding Award (22-28-HZ) Anna reported that the Conservation Commission is offering \$3,300 in Hazard Mitigation Funding to complete at least 10 home site assessments by 2/28/22. This offer is a result of Wendy attending a training regarding home ignition zone assessments. This funding helps to bridge the gap while we wait for DNR to either extend or offer another grant likely in September.

 - A. YBIP Grant Wymer Reservoir Stock Water Project extension to 12-31-2021
 - B. Manastash Creek Restoration Grant extension to June 30, 2022
